A HOME FOR THE HOLIDAYS CAMPAIGN WAS INSPIRED BY 8-YEAR-OLD DAVID. WHEN ASKED TO MAKE A CHRISTMAS WISH LIST, HE DREW A PICTURE OF A HOUSE.
