BUT LIKE MANY ALICE FAMILIES, SHE STRUGGLED TO FIND A SAFE PLACE SHE COULD AFFORD ON HER INCOME AT A CONVENIENCE STORE. GENEROUS DONATIONS FROM THE COMMUNITY HELPED TO PAY FOR SUPPORTIVE SERVICES LIKE THE SECURITY DEPOSIT, FIRST MONTH'S RENT, AND UTILITY DEPOSITS, FOR THE 10 FAMILIES.

THROUGHOUT THE YEAR OVER 2,000 VOLUNTEERS PROVIDED OVER 40,000+ HOURS OF SERVICE THROUGH THE UNITED WAY OF NSV WITH A TOTAL VALUE OF OVER \$1,000,000.
